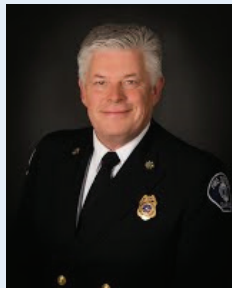

## Message from the Chief

I want to start this communication by thanking our firefighters who save lives and property

in our community every day. Many have dedicated their careers to the Fire District 3 community. We recognize these heroes with an award ceremony each year, and it is an honor to serve with them.

Daily operations are funded by a fire levy that is capped at \$1.50 per \$1,000 of assessed property value. Over time, the levy rate falls as property values rise to limit the fire district to roughly the same amount of revenue per year plus a 1% increase allowed by law. In 2022, our fire levy has fallen to \$1.34 per \$1,000.

At times, we ask our community to return the fire levy to a previously approved amount. This "lid lift" helps us respond to higher call volumes and increasing costs for service. We recognize that the current

economy is difficult for many. As a result, Fire District 3 will not be on the ballot this year. We will discuss a possible fire levy lid lift sometime in 2023.

Capital items, like fire stations, are funded by bonds. Fire District 3 and other agencies continue to ask the Clark County Council to pass impact fees associated with serving new growth. Impact fees help reduce the bond amount needed from our taxpayers.

Fire District 3 operates under a balanced budget and has long history of passing its financial and accountability audits by the state. Our Board of Fire Commissioners meet the 2nd and 4th Mondays of the month at 6:00 pm. This is your fire district, and we encourage you to attend.

## Wildfire Risk Reduction

Much of the eastern half of Fire District 3 is in the forested foothills of the Cascade Range. The area has many homes tucked away amongst the trees, some with very poor access and many with no visible addresses. Fire District 3 has a special program for property owners in this wilderness-urban interface to learn how to protect themselves and defend against wildfires.

Fire District 3 will come to your property

and conduct a fire risk survey free of charge. The recommendations will help protect your property from wildfires, and prevent a house fire from spreading into the forest.

Your participation in this program also helps Fire District 3. Planning for evacuation routes and emergency resources that may be needed is important to save lives and property. Please contact Fire District 3 at (360) 892-2331 to schedule your free risk assessment.

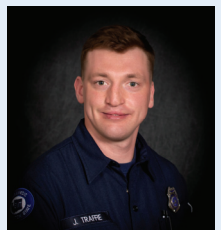

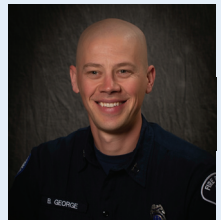
